SINCE OPENING IN 2017, WE'VE SERVED MORE THAN 600 WOMEN, PROVIDED HOUSING FOR OVER 200 PARTICIPANTS AND CELEBRATED MORE THAN 85 GRADUATIONS. 82% OF RESIDENTS HAVE REMAINED SOBER DURING THEIR PARTICIPATION.
